2. PAYMENT/ADDITIONAL INFORMATION:

- Bidding is an acceptance of the Terms & Conditions posted on nfpsna.com and the Auction Facebook Group. Bidding is your agreement to purchase breeding should you be the winning Successful BIDDER.
- Bidding starts at \$150 unless otherwise noted by Stallion Owner. Bidding increases in \$25 increments. All funds are in US dollars.
- PayPal invoice will be sent to the winning Successful BIDDER for the winning bid amount at the address provided within 24hrs of auction end and is due upon receipt or no later than 48hrs after receiving invoice.
- No PayPal account is required to receive a PayPal invoice from the NFPSNA and pay via credit card.
- Successful BIDDER will be purchasing, in full, the stallion services (also sometimes referred to as a stud fee) of the stallion should they be the highest bid at the time the auction closes, for use during the current 2024 breeding season unless Stallion Owner has otherwise noted in their listing.
- Upon NFPSNA's notification to Stallion Owner of payment of winning bid amount, Successful BIDDER and Stallion Owner will need to complete and sign the Stallion Owner contract and fulfill any terms under that Stallion Owner contract before Stallion Owner will ship semen or have a mare serviced.
- THERE ARE NO REFUNDS FROM THE NFPSNA ON WINNING BIDS FOR ANY REASON.
- The winning bid amount DOES NOT include any other fees such as but not limited to boarding, mare care, collection, booking, shipping, farm costs, chute fees, veterinary costs, etc., as may be applicable, which are the responsibility of the Successful Bidder.
- BIDDERS do not have to own pony size mares. MARES are not required to be registered or approved in any specific registry or be a member of the NFPSNA.
- No registrations into the NFPSNA are offered or promised to the auction participants unless the Stallion or Mare is currently registered with the NFPSNA as Full or Half New Forest Pony and is eligible as per the NFPSNA Rule Book at www.NFPSNA.com.
- Canadian and USA Stallions are participating in this auction. **PLEASE MAKE CERTAIN THE STALLION YOU ARE BIDDING ON IS IN THE SAME COUNTRY AS THE MARE YOU WISH TO BREED OR IS APPROVED TO SHIP OUTSIDE THEIR COUNTRY TO YOUR LOCATION. Some stallions may be Frozen or Live Cover.**
- It is the responsibility of BIDDER to contact the Stallion Owner for stallion breeding contract, stallion's availability, and all other information prior to placing a bid.
- Successful BIDDER, MARE OWNER and their Agents or assigns, by their participation in the 2024 Pony Stallion Service Auction (the "Auction"), hereby agree that he/she/they/it shall release and forever discharge the New Forest Pony Society of North America and its directors, officers, volunteers and agents from any and all liability, claims, demands, damages (actual and consequential) of every kind and nature, whether known or unknown, arising out of or in any way associated with any dispute between or among BIDDERS, Successful BIDDER, Mare Owner, Stallion Owner and their Agents.
